#### Author of the First Edition:

**Davorin J. Odrcic** is an immigration lawyer based in Milwaukee and principal owner of Odrcic Law Group, LLC. He specializes in removal defense, post-conviction relief for noncitizens, and advising defense attorneys on immigration. Davorin graduated from the University of Notre Dame Law School in 2001. He is a member of the American Immigration Lawyers Association and the Wisconsin Association of Criminal Defense Lawyers. He is also the recipient of the U.S. Department of Justice's Distinguished Public Service Award for his pro bono legal service for the family members of the victims of the violence at the Sikh Temple in Oak Creek, Wisconsin.

Davorin was the sole author of the first edition of Immigration Consequences of Wisconsin Offenses (2015). The book arose out of Davorin's work as program chair for the State Bar of Wisconsin's seminar titled Beyond Padilla v. Kentucky: The Immigration Consequences of Criminal Convictions. He has made several presentations at state judicial conferences in Wisconsin regarding the U.S. Supreme Court's decision in Padilla v. Kentucky and the immigration consequences of criminal convictions.
